### Termination of Aegon Global Sustainable Diversified Growth Fund (the "Fund")

We are writing to you in your capacity as a Shareholder in the Fund to inform you that the Directors of the Company have taken the decision to close the Fund with effect from 29 February 2024 (the "Effective Date").

# Why is the Fund closing?

The decision to close the Fund was taken in accordance with the terms of the Company's Prospectus, which permits the Directors to terminate a Fund if the Net Asset Value of the Fund is less than 20 Million USD.

Please note that as the Fund nears the Effective Date, the Investment Manager may deviate from the investment policy of the Fund as it sells off positions in which the Fund has invested. This may result in the Fund holding more cash than it would when trading under normal circumstances.

Please note that the Directors will use their discretion not to accept any subscription applications into the Fund between the date of this circular and the Effective Date.

### What will happen to my investment?

There are a number of options available to you, which are outlined below:

# 1. Switch

You may switch your shareholding free of charge into another fund of the Company into which you are eligible to invest. Information on our other funds, including the Key Information Documents, are available at www.aegonam.com. It is important that you read this information fully before making any investment decisions, taking independent advice, including tax advice, where appropriate.

If you choose this option, please notify the Administrator before **11.00** am (Irish time) on **26th February 2024** in accordance with the terms of the Prospectus.

# 2. Redeem your holding

You can redeem your shareholding free of charge at any time up to the Effective Date in accordance with the terms of the Prospectus.

#### 3. Take no action

If you do not switch or redeem your holding before **11.00** am (Irish time) on **26th February 2024**, your Shares will be compulsorily redeemed on the Effective Date. Settlement proceeds will be sent to your bank account within three Business Days of the Effective Date if we hold verified details.



#### Are there costs associated with the closure of the Fund?

With the exception of those costs related to the realisation of the Fund's underlying assets described above, the costs of closing the Fund will be borne by Aegon AM UK including the audit fee incurred from the closure date to the completion of the winding up of the Fund
