ESG reporting overview

At Aegon Asset Management we are active and responsible investors. We believe that responsible investment helps us to identify opportunities, manage risks and contribute positively to sustainable capital markets – all while meeting growing client expectations for ESG. The analysis of environmental, social and governance issues is central to our investment processes. With respect to asset-backed securities, we systematically integrate ESG considerations into our analysis of ABS transactions, where it sits alongside fundamental credit-risk analysis, valuation assessments and technical analysis. This provides an independent and comprehensive view of the investment. This ESG report includes three primary components:

- **ESG integration and characteristics:** Overview of our approach to ESG integration and summary of the portfolio's ESG profile based on our proprietary ESG methodology.
- **Active ownership activities:** Overview of engagement within the portfolio.
- **Carbon footprint:** Summary of the portfolio's carbon footprint including carbon impact metrics and intensity of holdings.

This report was prepared for the European ABS Fund on the portfolio as of 30 June 2025.

ESG integration and characteristics

Aegon Asset Management's ABS team performs the ESG analysis of ABS by evaluating collateral data, engaging with ABS originators, and assessing the transaction structure and the country of the collateral. The analysis eventually results in an ESG category score for each specific ABS transaction we assess. This ESG assessment consists of three pillars:

Collateral	Originator	Country
Evaluation of ESG factors embedded in the collateral, such as energy-efficient housing or social aspects of residential mortgages.	Assessment of ESG factors at the level of the originator, stemming from origination and servicing practices, products, and data handling.	Assessment of ESG factors at the country level, including the policy, legal and regulatory framework.

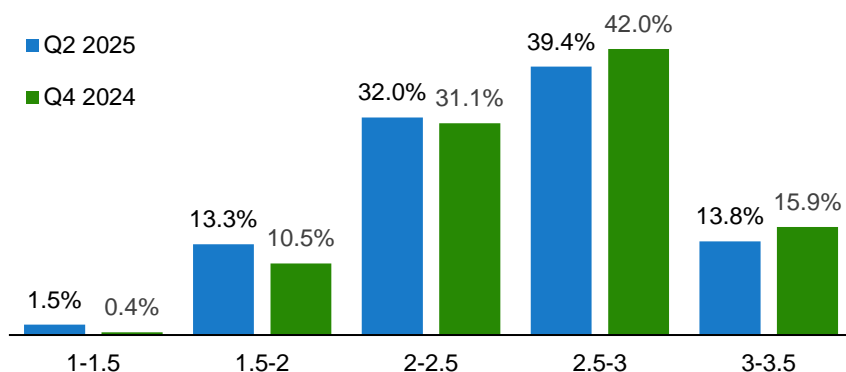
Each of these three assessments leads to an ESG risk category on a scale of 1 to 5, ranging from the highest to the poorest ESG standards. The risk categories for all pillars have different weights, leading to a final weighted average score on the transaction level. For our ABS funds, we do not invest in bonds with an overall ESG score in the categories with poor ESG standards (4 or 5).

Fund Objective

The Fund primarily invests directly or indirectly in asset-backed securities listed in euros or converted to euros, distributed over different issuers, collaterals, sectors and countries. The Fund invests primarily in RMBS (Residential Mortgage Backed Securities), CMBS (Commercial Mortgage Backed Securities), Consumer Loans, Car Loans, Credit Card loans, Whole Business (repackaging of companies / company divisions) and other asset-backed securities. The investment process is focused on the addition of value by means of an active selection policy for issuers, collaterals, sectors and countries.

Engagement

Before investing in an ABS transaction, the investment team actively engages with relevant transaction parties in ABS, CLOs, CMBS and RMBS. Relevant transaction parties are the seller, sponsors, originator, CLO manager and the servicer and other transaction parties.

Based on our Securitization ESG materiality matrix we have created customized ESG questionnaires for each sector, used in our engagement process. The results of the questionnaires are an important input for our ESG analysis of the originator, collateral, and structure risk. The ESG score of the specific transaction is again based on this ESG analysis.

Furthermore, engagement with the relevant transaction parties can provide opportunities to highlight ESG risks, inform the relevant parties on sustainability concerns, promote growth in sustainable business lines or advocate for changes in transaction structures that align with responsible investment standards. We classify our engagements as follows:

ESG general disclosure	Where we are seeking additional information from the relevant transaction parties on practices or products to make our own proprietary ESG assessment of a certain issuer.
Driving change	If our own proprietary ESG assessment raises ESG-specific concerns, we would seek specific performance improvements in a certain area (Environmental, Social or Governance), then we will classify the engagements by the specific topic.

We track engagements with a milestone-based approach:

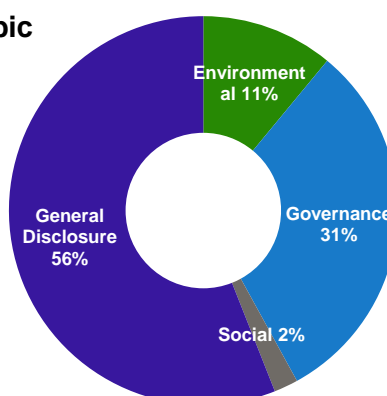
Milestone 1	We contacted relevant transaction parties and started the dialogue with the companies and sent the ESG sector-specific questionnaire.
Milestone 2	We received an adequate response on our questions and concerns.
Milestone 3	If needed, we engaged in further dialogue on specific concerns.
Milestone 4	The relevant transaction party responded adequately to our concerns and took relevant actions. This is the concluding step of Driving change.
No further action required	If we obtained satisfactory responses from the relevant transaction parties on our ESG-related questions and concerns, there is no further action required and we can conclude our engagement. This is the concluding step of ESG General disclosure.

Engagement activity

In the one-year period ending 30 June 2025, we engaged with 78 issuers in the portfolios for 100 engagements. Below we break this down by milestone and topic.

Investment policy and risks

Investment Policy

This fund is actively managed. The Fund will seek to achieve its investment objective by investing at least 70% of its net assets in asset-backed securities. Asset-backed securities are a type of debt security such as bonds or notes whose value and income payments are derived from an underlying pool of assets held by the issuer. The underlying pool of assets is referred to as 'collateral'. The Fund may hold bonds and notes with various types of collateral, but some examples include residential mortgages, commercial mortgages, consumer loans, car loans, credit card loans, student loans and corporate loans, such bonds will not embed any leverage.

The Fund will invest at least 70% of its net assets in bonds with a credit rating which is deemed to be 'investment grade', defined as meeting one or more of the following rating criteria: Baa3 or higher by Moody's Investor Services (Moody's); BBB- or higher by Standard & Poor's Rating Services (S&P) or Fitch Ratings Inc (Fitch).

The Fund will invest predominantly in bonds or notes issued by issuers located within Europe, but may also invest in bonds or notes issued by issuers located outside Europe.

The Fund will invest in assets denominated both in Euros and in other currencies. Where non-Euro denominated assets are held, the Investment Manager will seek to hedge the associated currency risk back to Euros.

The benchmarks of this fund are Bloomberg Barclays Capital Euro Asset Backed Securities Floating Rate Note Composite Index and the Bloomberg Barclays Capital Euro Asset Backed Securities Fixed Coupon Composite Index.

The Fund's (cash) benchmark is used as a reference to measure the Fund's performance.

Risks

The main risks are:

- (i) changes in the market's perception of the pool of underlying assets (or collateral) backing the security;

- (iv) the speed at which loans which form the collateral are repaid.
